

Natural gas imports & exports in Spain by country



August 2015

This month, natural gas net imports slightly decrease (-0.5% compared with August 2014) down to 23,668 GWh. Whilst LNG net imports drop 9.7%, those brought in by pipeline register a year-on-year increase of 5.8%.


In August, natural gas imports reach 30,971 GWh, 9.6% more than imports in August 2014. LNG imports record a drop of 15.8%. Geographically, only imports from Africa rise (+66.8%), highlighting those from Nigeria (+227.4%). Imports from Europe and Eurasia fall 58.6%, as do those from Central and South America (-51.7%) and Middle East (-39.5%).

In the year-to-date, 58.7% of all imports (down by 6.6% year-on-year) come from Algeria, main origin of gas imported to Spain, followed by Nigeria, Qatar and Norway (11.1%, 9.5% and 9.1%, respectively).


Natural gas exports reach 7,302 GWh this month, standing out exports to Pakistan (996 GWh) for the first time since there is available data (2010), representing 13.6% of total exports. This month, LNG exports continue to drop (-30.2%) down to 2,851 GWh, recording a 7-month drop.

Slight drop of natural gas net imports (-0.5%) in August 2015


Import weight by type of supply




