



Natural gas imports & exports in Spain by country

December 2017

In December, natural gas net imports fell by 5.9% compared to December 2016, reaching 34,696 GWh. LNG net imports decreased (-16.8%), whilst those made through pipeline increased (+7.3%). Overall, in 2017, natural gas net imports rose by 11.7%.

This month natural gas imports diminished (-7.0% vs. Dec-16; 37,237 GWh) because of the decline in LNG purchases (-16.6%; 45.2% of the total). The remaining 54.8%, made through pipeline, increased by 2.8%.

By geographical areas, Middle East (+39.0%) and North America increased their supplies, whilst Africa (-16.4%), Central and South America (-9.0%) and Europe and Eurasia (-8.7%) decreased. The main natural gas suppliers to Spain in 2017 were Algeria (48.2%), Nigeria (12.5%), Peru (10.1%) and Norway (9.9%).


Natural gas exports stood at 2,541 GWh in December, having registered a year-on-year decline of 19.7%. Pipeline exports accummulated year-on-year declines for 7 months in a row (-21.1% vs. Dec-16); LNG exports grew by 101.9%.


In 2017 exports dropped by 27.7%, of which 94.9% is through pipeline and the 5.3% remaining is LNG.

Import weight by type of supply









