



Natural gas imports & exports in Spain by country

October 2016


Net imports of natural gas fall slightly (-0.5%) to 26,481 GWh this month, 7.4% higher than in September. Increases in LNG imports (+6.7%), while those made through the pipeline (-5.5%) decrease.

In Octobre, imports fall (-2.1% vs. Oct-15, 29,238 GWh), reaching 40.2% of net supplies. By geographical area, supplies from Central and South America continue to rise, all of them from Peru (9.9% of the total). Likewise, imports from Europe and Euroasia increased (+40.3%), due to the rise in Norway (12.6% of the total). However, supplies from Africa (-16.4%) decreased as a result of the reduction in both Algeria and Nigeria (-18.6% and -9.5%, respectively). In the YTD, the main suppliers of natural gas to Spain are Algeria (57.8%), Nigeria (14.8%) and Norway (10.7%).


Exports stand at 2,757 GWh (-15.2% vs. Oct-15), declining year-on-year in the last seven months, decreasing both liquid (-85.2%) and pipeline exports (-11,8%). In the year-to-date, exports decreased by 21.4%, with 95.2% by gas pipeline and the remaining 4.8% LNG.

Import weight by type of supply




Import distribution by geographical areas January-October 2016


