



Natural gas imports & exports in Spain by country

October 2015


This month, natural gas net imports (26,617 GWh) decrease 2.6% compared with October 2014. Whilst LNG net imports rise 13.5%, those brought in by pipeline register a year-on-year drop of 11.5%.

Natural gas net imports to Spain decrease again (-2.6%) in October 2015 In October, natural gas imports amount to 29,862 GWh, down 17.2% in comparison to October 2014. 63.0% of imports were brought in by pipeline while the remaining 37.0% were LNG imports.


In the year-to-date, main natural gas suppliers are Algeria (58.9%), followed by Nigeria (12.3%), Qatar (9.1%) and Norway (8.9%). Nigeria is the only country that registers a positive year-on-year variation (+40.8%) compared with the same period of 2014.

This month, natural gas exports reach 3,245 GWh (-62.8% vs. October 2014). LNG exports, that represent solely 1.6% of total exports, register a 99.3% year-on-year drop. In the year-to-date, LNG and NG exports represent 27.5% and 72.5% of the total, respectively.


Import weight by type of supply




Import distribution January - October 2015**

Nota 3: In order to adapt to European legislation, since January 2015, the concept of gas transit contract has been changed, being considered hereinafter as import and export. Consequently the 2014 and 2015 data would not always be comparable.
