

Spanish crude oil imports by country

April 2016

Crude oil imports in April (5,283 kt) decrease -0.8% vs. April 2015

In April, fall of crude oil imports to Spain (-0.8% vs. April 2015) to a total of 5,283 kt. Continuous decrease of imports from Central and South America (-41.5%), with crude oil from Brazil not having been imported, for the first time since October 2014. Similarly there is a fall from Africa supplies (-21.3%), despite having two of the main suppliers of the month (Nigeria and Angola).

The rest of the areas grow appreciably, North America (+47.3%), with imports from the US for the first time since 1996, Europe and Eurasia (+46.4%) on the contributions of Kazakhstan and the United Kingdom, and Middle East (+15.7%), to a lesser extent, with imports from Iran three times higher than those of March 2016.

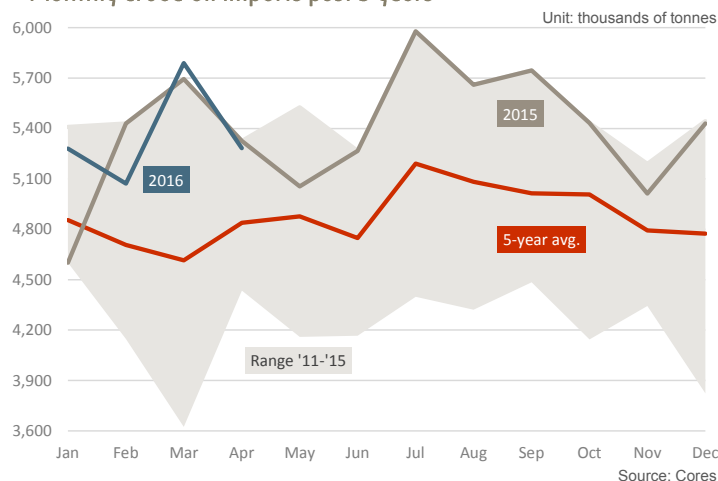
Africa remains the main supply area in all three periods, although only in the rolling year shows a slight growth. The only area with decreases in all periods is again Central and South America, remaining as the lower supply area.

This month 26 types of crude oil from 17 countries have been imported.

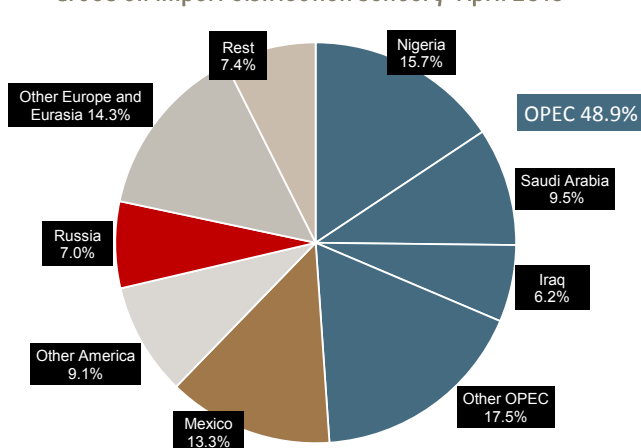
The main suppliers were Mexico (15.2%), Nigeria (12.0%) and Angola (10.2%).

Imports from countries belonging to OPEC decreased in April by -18.2%, representing 50.2% of the structure, while non-OPEC countries increased by 26.3%.
