

Crude oil Spanish imports by country

December 2013

Crude oil imports in Spain dropped once again in December (-23.4% compared to December 2012), reaching 3,751 kt, the lowest monthly amount since March 2011. The drop in imports from Mexico is particularly notable (-70% compared to December 2012).

Total imports for the year declined by 1.7%. In December 22 types of crude oil from 17 countries were imported.

OPEC country imports decreased in 2013 (51.8 % of total imports) -4.9 points with regard to 2012

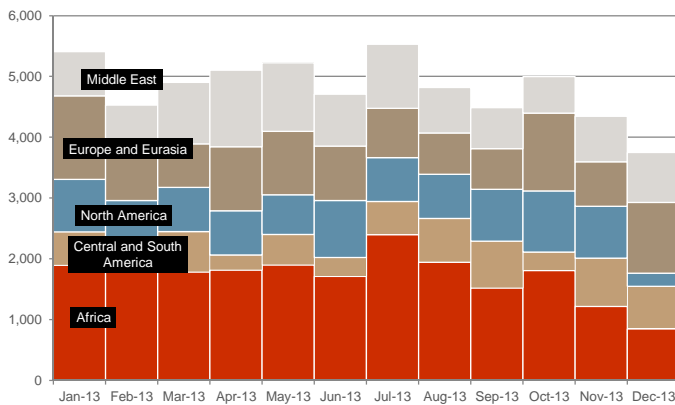
Saudi Arabia was the top supplier in December (19.8% of the total). In 2013, Mexico was the leading supplier country for crude oil (15.3%), followed by Saudi Arabia, Russia and Nigeria. These four countries represent 56.7% of total imports in this period.

OPEC country imports continued to drop, both for the month and for the year. 29,964 kt were imported from OPEC member countries in 2013, representing 51.8 % of total imports, 4.9 points below those of 2012 when they represented 56.7% of the total.

By geographical area, African imports declined once again (-53.4% compared to December 2012). Even so, in 2013, Africa continued to be the leading supply region (35.9% of the total).

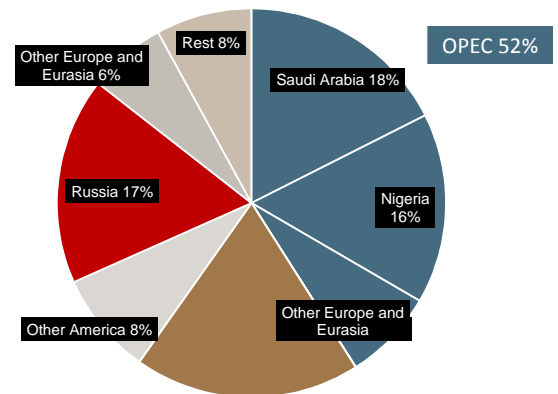
Crude oil imports by geographical area
