



Crude oil imports to Spain in 2017 (65,843 kt) surpassed the ones in 2016 (+2.6%)

Spanish crude oil imports by country

December 2017

This month 4.872 kt of crude oil were imported to Spain, a 9.2% less than in December of 2016. The total imports in 2017 (65,843 kt; +2.6 vs. 2016) were the highest since available data.

In December 34 types of crude oil were imported from 18 countries.


Nigeria (795 kt) was the main crude oil supplier to Spain, seconded by Libya (783 kt), which reached the imports historical maximum. Same situation occurred for Iran (561 kt) and Norway (401 kt).

The first oil supplier in 2017 was Mexico (14.6% of the total; +4.3% vs. 2016), followed by Nigeria (14.4%; +16.9%) and Saudi Arabia (9.7%; -3.2%). Imports originating from Norway, Iran and Kazakhstan outstood, which in comparison with 2016, rose 181.4%, 74.4% and 54.9% respectively.


Crude oil purchases from the OPEC country members reached 57.0% of the total imports in December of 2017, having increased by 9.4%. The year cumulative ascended to 6.8% and represented 53.3%.

In the month, uniquely the supplies from Africa grew (+22.9% interannual), having outstood the descents in North America (-29.8%) and Central & South America (-67.6%), which showed the lowermost entries since October of 2011. In 2017, Africa (32.6% of the total) is the main provider, followed by Middle East (22.5%) and Europe & Eurasia (18.8%).
