

Spanish crude oil imports by country

February 2017

In February 5,101 kt of crude oil were imported, slightly superior quantity than in February 2016 (5,072 kt). It is highlightable that during this month, maintenance operations were carried out in several refineries.

30 types of crude oil were imported from 20 different countries.

Mexico remained as the main supplier of crude oil to Spain, representing the 20.0% of the monthly total, notably over the rolling year (15.6%) with a monthly variation of 73.2%. The following country was Nigeria, despite its drop of 12.7%, it still signified a 15.0% of the total.

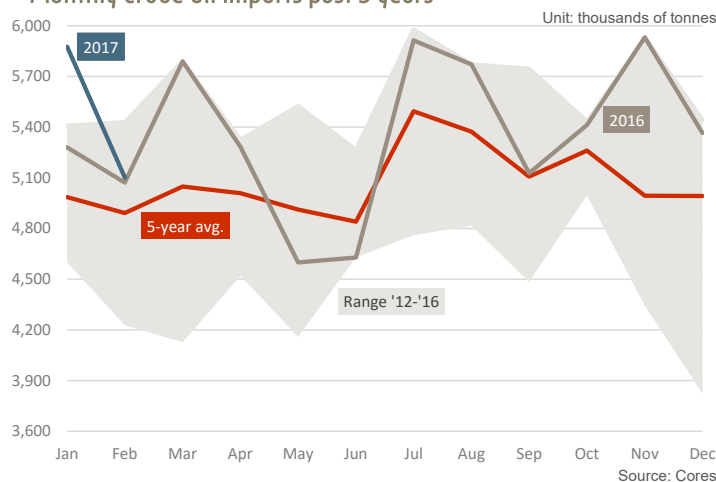
49.7% of the imports belonged to the OPEC countries, which remained moderately inferior as the ones registered in January (2,649 kt). This proportion lessens in the year-to-date cumulative (47.2%) as well as in the rolling year (46.6%).

By geographical area, it outstands the growth of the supplies from North America (+86.7% in February, +98.7% year-to-date and +26.0% on the rolling year); the decrease in Central & South America (-34.9%, -0.9% and +33.6%) and the decline in the Middle East for the second consecutive month (-0.4%, -0.9% and +33.6%).

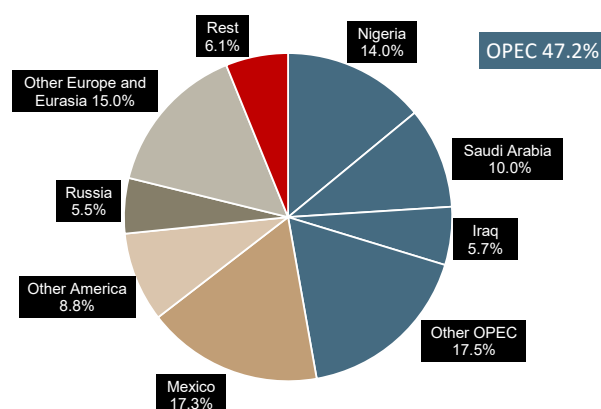
Nonetheless, Europe and Eurasia augmented (+12.7%, +24.3% and +11.3%) whilst Africa diminished (-21.2%, -19.6% and -22.4%).
