



Crude oil Spanish imports by country October 2014

Crude oil imports increase again in October

+3.7%

This month, 31 crudes from 18 countries were imported.

For 2014, main suppliers remain Nigeria (16.8%), Mexico (14.2%) and Russia (13.4%).

In the year-to-date, crude oil imports from OPEC countries keep moderating the drop registered for the year (-3.4%), due to the increases in the past three months. However, imports from countries outside OPEC maintain a positive variation (+1.2% in 2014), despite the drop registered in October (-6.9% vs. October 2013).

In October, crude oil imports increased again (+3.7% vs. October 2013) reaching 5,182 kt. Imports from all geographic areas rose, except those coming from North America (-30.3%). The escalation of imports from Central and South America stands out (+116.8%). Also notable are the increases registered in imports from Colombia (+18.8%), Libya (+28.5%) and Nigeria

(+80.7%), the latter being the main supplier for October. Imports from OPEC countries increased 18.3% regarding the same


Geographically, Africa remains the main area of crude oil supply in the rolling year (35.2%), mainly due to Nigeria's and Angola's weight in the structure (16.6% and 8.0%, respectively), followed by Europe and Eurasia (21.3%), Middle East (15.1%), North America (14.5%) and Central and South America (13.9%)
